



Pointe Schools Transportation Agreement

By signing below, I acknowledge and agree to the following terms and conditions regarding my child's use of the transportation services offered by Pointe Schools ("Pointe"):

I understand that Pointe is not required to provide transportation for its students under Arizona law, but has chosen to provide limited transportation services for the convenience of its parents and students.

I understand that Pointe does not provide supervision at the bus stops.

I understand that I am solely responsible for the safety and behavior of my child(ren) before he/she/they is/are picked up by the bus driver in the morning and after he/she/they is/are dropped off by the bus driver in the afternoon.

I understand that Pointe requires that parents be waiting at the bus stop for the bus to arrive and it is my obligation to do so. I further understand that the bus driver has no obligation to, and will not, wait with a child beyond the scheduled drop-off time.

I understand that, if my child is not picked up from the school, Pointe will take action under the Pointe Schools' Pick Up Policy (see student handbook).

I understand that Beeline Transportation reserves the right to change the published arrival/departure times in response to traffic conditions and other factors. Registered riders will receive an updated schedule as soon as it is available.

I understand that I should anticipate delays during the first 2 weeks of school.

Although Pointe has taken precautions to prevent an interruption of bus services, I understand that unavoidable interruptions may occur. In such an event, a representative from the bus company or Pointe will make reasonable efforts to contact parents with information.

I understand that: students are expected to sit in assigned seats and obey the school bus rules listed below, including all of the Pointe school rules; failure to follow the school bus rules or failure to pick up students in a timely manner may result in a loss of bus riding privileges or other disciplinary action in the sole discretion of Pointe; and any damage to buses caused by a student will result in a fee and/or fine to the student and the parent and/or the guardian of the student. I agree to pay for damage caused by my child(ren).

School Bus Rules:

1. Always conduct yourself with respectful and polite behavior.
2. Obey directions given by the bus driver.
3. Follow all school rules.
4. **Stay seated, facing the front of the bus** with your feet on the floor.
5. Keep hands, feet and objects to yourself and inside the bus.
6. Do not use unacceptable language at any time.
7. If it isn't allowed at school, it isn't allowed on the bus! Prohibited Items: Any item forbidden at school, open food, animals, glass, skateboards, paintballs, laser pens, balloons, etc.

I understand that Pointe is not responsible for lost or damaged personal property items brought onto the bus.

I understand that all fees for transportation are non-refundable and that all fees must be delivered to the Administrative Assistant at my child(ren)'s campus by the 1st school day of each month. Debit cards or cash are the only accepted methods of payment.
